#### DESCRIPTION OF THE DREADFUL EARTHQUAKE IN CALABRIA IN 1783,

The shock which the Calabrian coast experienced on the morning of the 5th of February, 1783, had been highly detri-mental to the town of Scilla, and levelled with the dust most of the houses situated on the upper range. The castle had also suffered considerable damage; it was the residence of the Prince of Scilla, whom advanced age and infirmities had rendered almost indifferent to the fate which appeared to threaten his existence, in common with that of the whole population, He had determined to await the event before the crucifix in his chapel, but was persuaded to leave the walls of a mansion which appeared scarcely able to remist further concussion, and seek his safety in flight to-wards the mountains, where he possessed a magnificent residence, called La Melia; but the road that led out of the town was so incumbered with the ruins of the buildings which had been overthrown, that it was resolved to defer his departure until the following day; and a temporary and apparently secure asylum was sought on the strand of one of the two small bays which are separated by the castle, and form harbours for the fishing-boats. To the largest of these, on the southern side of the promontory, this Nobleman retired, and prepared to pass the night in a felucca, which had been hauled up on the sand,

with all the other vessels beloning to the place, serving as receptacles for the remains of property or household goods saved by the unfortunate owners out of their fallen habitations. Here all the surviving individuals had assembled, and, after a day of terror, hoped to pass a few hours of comparative ease and tranquility. The Ave-Maria had been said, in which the feudal despots and all his vassals, now reduced to one common level of humiliation by the visitations they apprehended had joined with all the fervour of penitence and fear. The cries of motherless babes, and the lamentations of childless parents had subsided with the commotions of the earth, while grief, terror, and even despair, lost their power of excitement, and all had sunk under the languor of bodily as well as mental exhaustion. Not a breath of air disturbed the stillness of the atmosphere; not the slightest ripple was audible on the surface of the sea: it seems as if the elements, mankind, and nature berself, had wasted their energies, and yielded to the necessities of repose.

At about half-past seven a distant but loud crush proclaimed some new disaster, & awakened to a fearful state of suspense all the eilent sufferers. A powerful recur-rence of the morning's shocks had severed a large portion of Mount Baci, which forms the next promontory towards the south, & dashed its shivered mass into the ses. The darkness precluded an immediate communication of this event to the trembling population on the sands, and also shrouded from their knowledge the anticipation of its consequences. They were roused by the earthquake; but, extended on the beach, and out of the reach of all buildings, they thought themselves comparatively secure from real danger. A low rustling noise was soon heard, and gradually but rapidly increased to the roar of the most impetuous hurricane. The waters of the whole canal, impelled by the pressure of the fallen mountain, in a single wave, had rushed with irresistible force over the opposite point of the Faro, which it entirely inundated. Thrown back towards the Calabrian coast, it passed with impetuosity over the shores of Scills, and, in its retreat to the bosom of the deep, swept from its surface every individual who had thought to find safety in the barrenness of its sands. One abhorreut shriek, uttered by the united voices of 4,000 beings, thus enatched to eternity, re-echoed from the mountains, and the tremendous wave, returning a second and last time, rose to the elevation of the highest houses that yet remained entire, and buried many of them in masses of mud and sand, leaving on their flat roofs, and among the branches of the trees, which grew out of the impending rocks, the mangled bodies of the victims it had destroyed. But these were not many; for the mase, including the Prince of Scilla, were never seen or heard of more - Craven's Tour through the Southern Provinces of the Kingdom of Naples.

#### ANOTHER FIGHT

Between SPRING and LANGAN. Memorandum of an Agreement made between John Langan and Thomas Winter Spring, at Thomas Cribb's, Panton-street Haymarket, March 2, 1824.

WE, John Langan and Thomas Winter Spring, agree to fight on Tuesday, the 8th June, 1824, for five hundred pounds aside, on a twenty four feet boarded stage; to be a fair stand-up fight, half minute time; an umpire to be chosen by each party, and a referee to be chosen on the ground by the umpires. The fight to take place within one hundred miles of London, and the place to be named by Mr Jackson; the men to be in the ring between the hours of twelve and one o'clock at noon, unless the hands of the stakeholder, Mr James Soares ; fifty pounds more to be made good on the 13th of March, instant, at John Randall's Hole-in-the-Wall, Chancery-lane; a further deposit of two hundred pounds to be made good at Thomas Cribb's on Saturday, the lat of May, and the whole to be made good at Thomas Belcher's Castle Tavern, Holborn, on the 1st June, 1824the deposits to be made good on the days beforementioned, between the hours of eight and ten in the evening ; either party failing, to forfeit the deposit down.

The stage to be boarded with deals, not less than three inches thick, without turf, and to be six feet from the ground, as in Cribb's battle. The bottle-holders and seconds to retire to the corners of the stage when the men are placed at the scratch, every round, and to remain there till oue or both of the men are down.

The expenses of this stage to be paid equally between Langan and Spring.

It is further agreed, that when the whole of the money is made good it shall be transferred to the hands of Mr Jackson.

#### MOUNT HOLLY, (N. J.) March 17.

Important to Nurses .- It should be generally known that laudanum, by long atanding, deposists a sediment which ren-ders it dangerous. Many valuable lives have been lost from ignorance of this fact. On the 12th instant, Dr. Cox, of Black Horse, was called to an infant, four months old to whom four drops of laudanum had been given, three or four hours before. Ou examination the vial was found to contain a torpid fluid, no doubt many times stron-ger than clear laudanum. The child appeared in the agonies of death-oppressed with irresistible sleep-emetics would not operate; but by the prompt introduction of an elastic tube into the stomach, and the use of a syringe and warm water, its contents were completely washed out. In a short time the infant was much relieved ; and in the course of a few hours quite restored.

### From an American Almanack.

To destroy worms in fruit trees .- Take a half inch auger or bit and bore to the centre of every tree; then, by means of a paper tube, till the hole with sulphur, crowding it in with a small ramrod; then cut out a green limb from the same tree, & plug the hole. It will not require more than two spooufull of sulphur for each tree, and in 48 hours the worms will leave the remotest branches .- This process will also be beneficial for young fruit trees, even when not troubled with worms : it renders them more thrifty. This process has been found infallible.

#### THE ALPINE HORN.

The Alpine Horn is an instrument constructed with the bark of the cherry-tree, and which, like a speaking-trumpet, is used summit of the Alps, the shepherds who dwells highest on those mountains, takes his horn and calls aloud, " Praised be the Lord !" As soon as he is heard, the neighbouring chepberds leave their huts and repeat those words. The sounds last many minutes, for every echo of the mountains and grotto of the rocks repeat the name of God. How solemn the scene ! The Judge paused a few momente, and then addressed the Jury. "Gentlemen of the Jury, thirty years ago, I and some companions, as thoughtless as myself, went to this woman's dwelling, then a public house, and after enjoying ourselves, found we had no means to discharge the reckoning. I had recourse to stratagem. Observing a child ill of an ague, I pretended I had a spell to cure her. I wrote the classic line you see on a scrap of parchment, and was discharged of the demand on me by the gratitude of the poor woman before us, for the supposed benefit; nature doubtless did much for the patient, the force of imagination the rest.
